The Mayor is issuing the following rules for the said meeting in order to promote social distancing as required in the Governor's Executive Orders and Disaster Proclamations as well as state guidelines. The Capacity guidelines will only allow a limited number of public members at the meeting, and it is possible no public may fit.

A. A web form will be available on the City's website which will let members of the public to give comments on any aspect of the foregoing that they would like to comment upon and then space to type the comment. The form will ask for the person's name and city of residence.

B. Information will be printed on the meeting agenda and prominently on the City's website about how to provide public testimony, including a link to the web form. The information will be in substantially the following form: "NOTICE REGARDING MEETING AND PUBLIC TESTIMONY RULE MODIFICATION DUE TO COVID-19" pursuant to the recently amended Illinois Open Meetings Act allowing less than a quorum in-person attendance by members of a public body during the duration of the Gubernatorial Disaster Proclamation, all members of the Delavan city council will likely not be physically present for the September 29, 2020 Regular City Council Meeting, but will instead be participating in the meeting through audio/video access using a virtual meeting platform.

C. The instructions for addressing the city council in this manner are provided as part of the agenda posting. Comments received between 5:00 p.m. and the adjournment of the hearing on September 29, 2020 will be read aloud during the hearing. Comments will be read aloud in the order in which they were received. Comments will be limited to 2,700 characters each. Any comments unable to be read due to time limits will be published online as soon as practicable.
